On March 29, 2019, the State Water Resources Control Board (State Water Board) released a revised draft order amending the terms and conditions of the U.S. Bureau of Reclamation's (Reclamation) water right permits for the Cachuma Project (Permits 11308 and 11310 (Applications 11331 and 11332)). On April 4 and 5, 2019, respectively, the Cachuma Conservation Release Board, Santa Ynez River Water Conservation District (SYRWCD), City of Lompoc, SYRWCD Irrigation District No. 1 (collectively the Local Interests) and the U.S. Bureau of Reclamation (Reclamation) submitted requests for an additional 45 days to comment on the revised draft order amending Permits 11308 and 11310 (Cachuma Project). The Local Interests and Reclamation state that the additional comment time is necessary since the revised draft order contains substantial revisions.

Although the revisions to the draft order are primarily descriptive, an additional 30 days to submit comments on the revised draft order amending Permits 11308 and 11310 has been granted. Comments on the revised draft order must be received by the State Water Board at 12 Noon on May 29, 2019.

As a reminder, interested persons and parties may only submit written comments on the changes in the revised draft order and the possible drought off-ramp conditions.
