Board Letter Ruling, March 14, 2012

Dear Ms. Farwell:

This letter responds to the State Water Resources Control Board (Board) subject letter that ruled on the motion filed by Santa Ynez River Water Conservation District Improvement district No. 1, the Cachuma Conservation Release Board, and the Santa Ynez River Water Conservation District (the Cachuma Water Agencies) to strike certain rebuttal testimony proposed by California Trout (CalTrout) and the National Marine Fisheries Service (NMFS) for the hearing scheduled for March 29 and 30. The Board ruling maintained the scope of the hearing, consistent with the Board's Notice of Public Hearing, and also has allowed for sur-rebuttal witnesses to be heard provided that an outline of testimony is received no later than noon on March 26, 2012.

Based on the Board's ruling, Reclamation will not be offering any sur-rebuttal witnesses and stands on the testimony and closing arguments that Reclamation provided during the main phases of these Cachuma hearings, and therefore, has no objection to the inclusion of the Board's 2011 Final Environmental Impact Report being entered into the administrative record.
