SCHEDULING OF HEARING REGARDING ADMINISTRATIVE CIVIL LIABILITY COMPLAINT FOR FAILURE TO FILE 2010 ANNUAL WATER USE REPORT FOR LICENSE 682 BY JULY 1, 2011, CALAVERAS RIVER, SAN JOAQUIN COUNTY

A hearing on this matter by the State Water Resources Control Board (State Water Board or Board) has tentatively been scheduled to commence on one of the following dates: **February 26, 2014, March 17, 2014; or March 24, 2014**. If you have a conflict with any or all of the above hearing dates, please let me know immediately, as the Board must schedule its hearings well in advance. A request for a change should be accompanied by the reason for the conflict. An alternative hearing date will only be provided for the most compelling reasons.

The purpose of the hearing is to receive evidence relevant to determining whether to adopt an order imposing administrative civil liability and, if so, whether in the amount of \$25,000, or some other amount.
