An evidentiary hearing will be held on **Thursday, June 19, and continue if necessary on Friday, June 20, 2008**, at the Cal/EPA Building in Sacramento, California.

The Division of Water Rights will shortly provide a detailed hearing notice with times, locations and procedures. Parties to the hearing should plan to submit **Notices of Intent to Appear by 12 noon, March 14, 2008**.

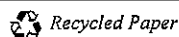
