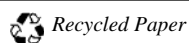
Persons filing a NOI and intending to present only policy statements may do so at the April 1, 2008 hearing in Monterey or may do so by filing a written statement with the State Water Board no later than the close of business on June 18, 2008. No policy statement will be accepted during the hearing commencing on June 19, 2008.

As instructed by the notice and in item #4 of the notice's attachment entitled, "Information Concerning Appearance at Water Right Hearing", no later than **noon, Friday, May 30, 2008**, each participant shall submit to the State Water Board either: seven paper copies of each of its exhibits or five paper copies and one electronic copy of each of its exhibits (total email attachment limitation: <15 MB). Each participant shall also serve a copy of each exhibit on every participant identified on the service list. Participants may serve those parties who agree to electronic service with an electronic copy of exhibits. Participants must serve paper copies of exhibits on those participants who do not agree to electronic service.
