SCHEDULING OF HEARING ON ENFORCEMENT ACTION ENF00131 - ADMINISTRATIVE CIVIL LIABILITY COMPLAINT AND DRAFT CEASE AND DESIST ORDER REGARDING UNAUTHORIZED DIVERSION OF WATER WITHIN NAPA RIVER WATERSHED IN NAPA COUNTY

A hearing on this matter by the State Water Resources Control Board (State Water Board or Board) has tentatively been scheduled to commence on **August 31**, **2015**. A request for a change should be accompanied by the reason for the conflict. An alternative hearing date will only be provided for the most compelling reasons.

The purpose of the hearing is to receive evidence relevant to determining whether to adopt an order imposing administrative civil liability and, if so, whether in the amount of \$13,000, or some other amount; and whether to adopt, with or without revision, the March 15, 2012 draft Cease and Desist Order against Michele Amendola and Jack Chandler.
