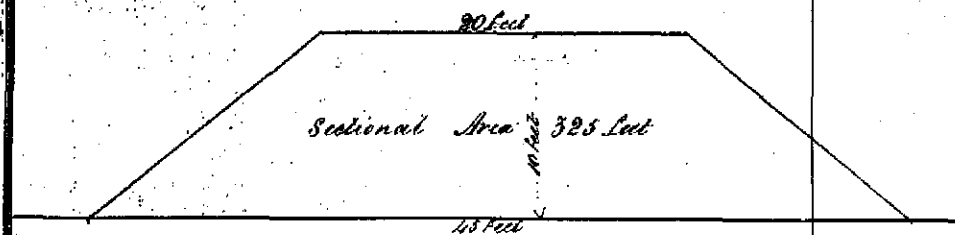

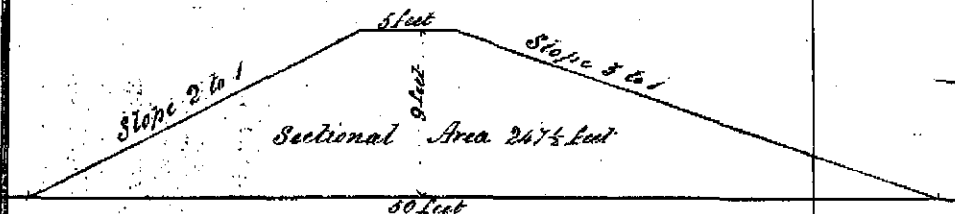

Gentlemen

They leave to report
to you that I have surveyed and located
the lines of levee necessary to the reclamation
of the lands embraced within your
district, and I herewith submit a
Map of the same, with the following
plan of the form and size of the
proposed levees

Section of Dry Earth Levee

The plan contemplates joining the levee of District No 62 at each end thereof, as I am informed you have arranged with the owners of the lands in that District to make such union.

On the general line of the Levees of your District I found twenty one sloughs, besides a number of cuts and depressions, which it is necessary shall be dammed and filled up, to make the reclamation complete; it is also intended to place flood gates at most of these sloughs.

I submit the following estimate of the cost of the reclamation of said District on the plan heretofore mentioned as adopted by the board of Trustees.
