PERMITS 19163, 19164, AND 19165 (APPLICATIONS 26305, 26306, AND 26307)  
SHASTA RIVER IN SISKIYOU COUNTY

I have received a letter dated September, 2000 from Pete Scala, ranch manager for Emmerson Investment, Inc., with proposals for devices to measure the 1 cfs fish bypass required by Permits 19164 and 19165. Thank you for your prompt reply.

The measuring devices as proposed are acceptable, subject to maintaining the designated head on each orifice (water level up to top of boards or above) and provided that the orifices are kept free and clear of debris.

The installation schedule is also fine. Please submit photos for our files once installation is complete. At this time I have no plans to visit your project to see how the devices are working, as it is not likely that you will have water available for diversion under these permits for the rest of the current irrigation season. Perhaps I will make a visit next spring or early summer.

The last extensions of time for these permits were granted to the prior owner for the purpose of making diversion measurements. Consequently, I would still like to see written confirmation that Mr. Keith Dick (or another qualified person) will be assisting you in making measurements and keeping records for the next few years.

As I stated in my August 29, 2000 letter, I am enclosing forms for requesting extensions of time for Permits 19164 and 19165. Each petition requires a filing fee of \$50.00 payable to the Division of Water Rights. An environmental filing fee of \$850.00 is also required, payable to the Department of Fish and Game. I believe that only one \$850.00 fee will be required if the two extension petitions are received and processed together.


