
These dates may be used for either phase 1 or phase 2 of the hearing, as needed.

A number of people have inquired whether the SWRCB will hear policy statements in Sacramento on April 23, 2002. Persons wishing to make oral policy statements are strongly encouraged to appear on April 22, 2002, in Holtville, California. If due to special circumstances a person is unable to attend the hearing in Holtville, however, the hearing officer may set aside time on April 23, 2002, to hear policy statements in Sacramento. Policy statements may also be submitted in writing in advance of the hearing.

All other aspects of this hearing remain the same as set forth in the February 6, 2002, hearing notice. In particular, the deadlines for submitting Notices of Intent to Appear and hearing exhibits set forth in the February 6, 2002, hearing notice will not be extended as a result of the addition of hearing dates.
