SCHEDULE NO. 1

General Agricultural, Municipal and Miscellaneous Service

Applicable to:

- (a) Service where water is taken from the canals of the District for general irrigation use by lands or properties located within the Imperial Unit of the District.
- (b) Service where water is taken from the canals of the District for use by cities, incorporated or unincorporated, towns, private water companies, mutual water companies, and water utility districts for lands or properties within the Imperial Unit of the District.
- (c) Service where water is taken from the canals of the District for use by schools, churches, cemeteries, experimental farms, golf courses, and recreational activities directly connected with such agencies. (Except where charged under Schedule No. 3 or excluded in Schedule No. 10.)

Water Rate

For all water delivered
Schedule (a), (b) and (c)

\$15.50 per acre-foot

Stock Water

The minimum charge for delivery of
"stock water run" shall be equal to
one-half the above charge Schedule
No. 1 (a) above only

\$7.75 per day

SCHEDULE NO. 1-A

Mesa Agricultural Service

Applicable to service by irrigation on mesa lands within the Imperial Unit of the District. By "mesa lands" is meant all lands located above the 1030 contour line.

Water Rate

Stock Water

- D. The minimum charge for delivery of a "stock water run" shall be one half acre-foot times Schedule No. 1

Schedule No. 1-A applies to a, b, & c above only

Special Conditions

- (a) All lands receiving water service under this Schedule shall comply in all respects with Regulation No. 19 of the "Rules and Regulations Governing Distribution and Use of Water."

SCHEDULE NO. 2

Pump Service

Applicable to service to private pumping plants where water is taken from the canals of the District to be used for general irrigation for lands or properties within the Imperial Unit of the District.

Water Rate

The annual water rate per acre irrigated shall be:

6 A.F. per acre x the Schedule No. 1 Rate

Billing

The water user will order water as required and will be billed on a monthly basis for the number of acre feet delivered up to:

6 A.F. multiplied times the Schedule No. 1 Rate

SCHEDULE NO. 3

Pipe and Small Parcel Service

Applicable to service from any pipes which are installed to take water by gravity flow only from the canals of the District for general use, or for any service to small parcels from an open ditch within the Imperial Unit.

Annual Charge

- (a) For pipes with a diameter of 2 inches or less, or for service to small parcels from an open ditch Seven times Schedule No.1 per rate year
- (b) For pipes with a diameter of over 2 inches and not exceeding 6 inches, per acre Five times Schedule No.1 rate per year

Annual Minimum Charge - Schedule
3(b): 2 acre minimum charge per year

Special Conditions

- (a) In the event any of the above pipes serve more than one water user, each additional water user shall be subject to the annual charges provided for in this Schedule. Exceptions to these charges will be made in the event a single water user owns more than one house served by the same pipe.
- (b) Pump accounts used for water service to cattle and/or feed yards shall be charged on the basis of Schedule 3(b) whether water delivery is made by pipe and/or otherwise.
- (c) Water service to small acreage shall be charged on the basis of Schedule 3(b). Houses receiving water through private field head ditches during normal irrigations will not be charged under this schedule but may order regular Stock Water as needed.

SCHEDULE NO. 4

Wholesale Service

Applicable to raw water service to water users' associations within the Imperial Unit.

NOTE: This raw water service is not for drinking water use unless treated according to all applicable regulations.

Water Rate

For all water delivered

One acre-foot times Schedule No. 1

Special Conditions

Annual Rate Based on Gross Acreage. In those cases where, due to conditions existing in the customer's facilities for handling water, it is impractical for the District to install water measuring equipment, water service applicable to this Schedule shall be furnished on an annual charge per acre as follows.

Water Charge

For gross acreage of area served, per acre Eight times Schedule No. 1 per year
per acre

Annual Minimum Charge

Annual minimum charge to any water users' association shall be 2 acre minimum

SCHEDULE NO. 5

Reuse of Drainage Water

Applicable to water users receiving drainage water only within the Imperial Unit.

Rate

Upon prior approval from the District, those users receiving only drainage water will be excluded from any charges for service of drainage water.

SCHEDULE NO. 6

Stand-by Service (Water Availability Charge)

Applicable to lands within the service area of the District, which are entitled to water service in accordance with the District's Rules and Regulations, except lands not subject to assessment (City, County, State and Federal lands including public water districts).

Annual Stand-by Charge

For each gross acre, or fraction thereof, whether water is actually used or not	\$4.00
Less minimum allowance for any and all right-of-way considerations	<u>5%</u>
Net per acre charge	\$3.80

Special Conditions

- (a) Annual Billing. Billing for stand-by service will occur annually in advance of January 1, payable on a semi-annual basis. The date of delinquency is established as being February 15 and August 15 for the respective six-month periods.
- (b) Minimum Charge. There shall be no charge for parcels of 5.0 acres or less.
- (c) Private Water Agencies. Charges for acreage within the Imperial Irrigation District which are directly served by private water systems, mutual water companies, or other private agencies providing water service shall be collected from said agencies.

SCHEDULE NO. 7

General Industrial Service

Applicable to water service to all industrial users who divert water from the District's canal system within the Imperial Unit.

Exception: Where there is a signed contract between water user and IID Board of Directors.

Water Rate

For all water delivered

Five times Schedule No. 1

Annual Minimum Charge

Annual minimum charge shall be 5 times above rate

Drainage Limits

The limit on drainage is set at 5 percent of the total volume of water received within a billing period and the maximum allowable flow rate shall be 10 percent of the maximum flow rate of the water received but shall not exceed 672 gallons per minute (1.5 cfs).

Assessment for Excess Drainage

An assessment of three (3) times the General Industrial Service rate will be charged for excess water discharged into the District drain.

SCHEDULE NO. 8

Penalty for Adjusting Gates

Applicable to anyone who adjusts a delivery gate which results in a change in the amount of water delivered without prior authorization from the District.

Penalty Charge

For each delivery gate adjusted
without authorization

\$100.00 per gate

DRAINAGE RATES

SCHEDULE NO. 9

Charge for Drainage Service

Applicable to:

Facilities outside the Imperial Unit which require drainage into the District system.

Drainage Limits

The limit on drainage is set at 5 percent of the total volume of water received within a billing period and the maximum allowable flow rate shall be 10 percent of the maximum flow rate of the water received, but shall not exceed 672 gallons per minute (1.5 cfs). These limitations are set as guidelines and individual contracts may be written.

Drainage Rate

For all water drained into the
District system

\$250 per acre foot

Minimum Charge

A minimum charge per month is set at \$200 per discharge point.

Assessment Charge

An assessment will be charged at three times the drainage rate (\$750) for excess water discharged into the District drain.

SCHEDULE NO. 11

Drainage Construction

Applicable to:

The construction of drains as a part of the District's drainage system to provide a tile and/or surface drain outlet for each governmental sub-division of approximately 160 acres.

Drainage Rate

For contribution to the Capital
Improvement Account

\$30.00 per acre

District's Responsibility

The District will pay the difference in total cost of construction and the \$30 per acre paid by the landowner and will assume responsibility for all future drain operation and maintenance.

12-Hour Run

Applicable to:

All 12-hour runs

For all water used Schedule No. 1 rate shall apply.

Conserved Water

Applicable to:

Water delivered outside the District Boundary, inside Imperial County.

Water Rate

For all water delivered

\$370.27 per acre-foot*

*To be adjusted annually after 1988 in accordance with the Consumer Price Index (CPI)

*Based on \$250 per acre-foot at 1988 dollars, using all urban consumers CPI, U.S. City Average, all items, 1982 -1984 = 100
