### **HEARING PARTICIPATION**

IF YOU WANT TO TAKE PART IN THE EVIDENTIARY HEARING, you should carefully read the November 3, 2008 Notice's enclosure entitled "Information Concerning Appearance at Water Right Hearings." As stated in that enclosure, everyone wishing to present evidence at the hearing must submit a **Notice of Intent to Appear**, which must be **received** by the State Water Board no later than the deadline listed below. **If Irish Beach Water District fails to submit a Notice of Intent to Appear by the deadline specified in this notice, the State**

**Water Board will deem their request for a hearing regarding the proposed revocation to be withdrawn and the permit may be revoked without further notice.** Within one week after the deadline for Notices of Intent to Appear, the State Water Board will mail out a list of those who have indicated a desire to participate in the hearing and a copy of all Notices of Intent to Appear that were timely received by the State Water Board. The list is provided in order to facilitate exchange of written testimony, exhibits and witness qualifications in advance of the hearing. Only parties and other participants who are authorized by the hearing officer will be allowed to present evidence. Copies of witnesses' proposed **testimony, exhibits, lists of exhibits, and qualifications** must be **received** by the State Water Board and served on each of the parties who have indicated their intent to appear, no later than the deadline listed below.

Deadline for receipt of Notice of Intent to Appear.

**12 Noon, Wednesday, February 11, 2009**


Deadline for receipt and service of witnesses' proposed testimony, exhibits, lists of exhibits, and qualifications.
