ENFORCEMENT ACTION ENF00158 – RESPONSE TO REQUEST FOR HEARING

By certified mail dated June 12, 2012 (received June 18, 2012), the State Water Resources Control Board (State Water Board), Division of Water Rights (Division) sent you a notice of Enforcement Action ENF00158 (Notice), enclosed with an Administrative Civil Liability (ACL) Complaint and draft Cease and Desist Order (CDO). (Certified Mail No. 7004 2510 0003 9146 0620) The Notice specified that a written request for a hearing must be received by mail or delivered to the State Water Board within 20 days after receipt in accordance with California Water Code sections 1055, subdivision (b), and 1834, subdivision (b). By letter dated July 2, 2012 (received July 25, 2012), you requested a hearing on the above-mentioned enforcement matters. Despite its untimely receipt, your request for hearing on the ACL Complaint and draft CDO is accepted because the tardiness resulted from an unexpected postal error.
