All,

The Prosecution Team's witness Mr. Joey Howard, has graciously agreed to appear for this hearing. He will be driving from Ashland, Oregon. Other than witness appearance fees required for appearance in response to a subpoena, he is not being compensated for his appearance. The time he spends traveling and appearing is time he would otherwise spend performing engineering

services for compensation. To reduce the burden of attending this hearing, we are discussing scheduling with other parties. However, in the interest of minimizing the burden on witnesses the Prosecution Team requests a remote appearance by phone, video, or other methods. The Regional Water Quality Control Boards have used remote appearance to accommodate witness appearances. We believe a similar approach is appropriate for Mr. Howard considering the long distance and time necessary for his travel.
