On July 27, 2017, at my request, Nathan Voegeli and I spoke with you and Kerry Fuller by telephone regarding the draft lake and streambed alteration agreement associated with the Douglas and Heidi Cole's water diversion on Stanshaw Creek for Marble Mountain Ranch (Notification No. 1600-2017-0135-R1). The purpose of my call was to request that the Department and the Coles postpone the meeting you requested in July with Northern Region staff to discuss certain measures in the draft agreement in accordance with Fish and Game Code section 1602(b). On behalf of the Coles, you agreed to postpone this meeting until sometime after the State Water Resources Control Board issues a decision regarding the Cole's water rights related to Marble Mountain Ranch. As you know, the Board has rescheduled the hearing on this matter to begin on November 13, 2017.

Please confirm that I have accurately described the agreement we reached on July 27th, or contact me if you have any questions or concerns. I apologize for not sending this email to you sooner, as I intended.
