**CORRECTION TO STATE WATER RESOURCES CONTROL BOARD DECISION 1649
PARTIALLY APPROVING WATER RIGHT APPLICATIONS 31165 AND 31370 OF THE
SAN BERNARDINO VALLEY MUNICIPAL WATER DISTRICT AND WESTERN MUNICIPAL
WATER DISTRICT (MUNI/WESTERN), SANTA ANA RIVER**

It has come to our attention that the above-referenced decision contains a technical error that affects the description of the location of San Bernardino Valley Municipal Water District and Western Municipal Water District's (Muni/Western) point of rediversion (POR) #13, which is a POR from Lake Matthews.

Table B, attached to State Water Resources Control Board (State Water Board) Decision 1649, accurately described the section, township, and range of POR #13. The quarter sections and California Coordinates, however, were incorrect. Specifically, the quarter sections for POR #13, should have been described in the NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 12, Township 04S, and Range 06W of the San Bernardino Base and Meridian (SBBM), instead of in the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 12 and the coordinates for POR #13, should have been described by the California Coordinate System of 1983, Zone 6, as North 2,249,950 feet (ft.) and East 6,193,500 ft., instead of North 2,256,420 ft. and East 6,198,550 ft.

Pursuant to Water Code section 1124, the State Water Board "at any time may amend or modify a decision or order to correct any obvious typographical or clerical error or oversight . . ." The State Water Board has delegated this authority to the Deputy Director for Water Rights. (State Water Board Resolution No. 2007-0057, § 4.1.3.) In a letter dated October 4, 2007, the Deputy Director re-delegated this authority to the Assistant Deputy Director and to the Section Managers within each Section Manager's area of authority. (October 4, 2007 memorandum to All Water Rights Staff, § 4.1.3.)

Enclosed is a corrected Table B, which includes the change noted above. The corrected table replaces the original Table B on page 66 in State Water Board Decision 1649.

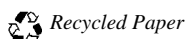
