Confirming our conversation today, the SWRCB expects that by October 4, 2002 Orange County Water District ("OCWD") will respond to only the three protests that the SWRCB has accepted. The protests which have been accepted are by City of San Bernardino Municipal Water District, City of Riverside, and the East Valley Municipal Water District. OCWD further understands that it is inappropriate to respond at this time to those protests which have not been accepted, including those of the City of Redlands and the Local Sponsors. However, it is OCWD's understanding that if those protests are accepted, OCWD will have 45 days from the date they are accepted to file a response.
