Notice is hereby given that L. H. Taylor thereunto duly authorized by the Secretary of the Interior, for and on behalf of the United States of America, claims all the unappropriated waters of Truckee River, both surface and underflow, at the place where this notice is posted, at all seasons of the year, to the extent of (1500) fifteen hundred cubic feet per second (Seventy-five Thousand (75,000) Miner's Inches measured under a four inch pressure);

That said water is claimed for irrigation and other beneficial uses on the lands within the basin of the Truckee, Carson, Humboldt Rivers in Washoe, Storey, Lyon, Churchill and Humboldt Counties in the State of Nevada;

That it is the intention to divert the said waters from the River at this point which is in the Southwest Quarter of Section 19, T. 20 N., R. 23 E., M. D. M., by means of a dam to be built in the channel to a height of about twenty (20) feet into a canal having a bed width of approximately twenty (20) feet and a depth of approximately thirteen (13) feet, and conduct in therein to points of use.

This notice is posted on the right bank of Truckee River at a point about 2000 feet below the sixth crossing of the Central Pacific Railroad in the Southwest Quarter of Sec. 19, T. 20 N., R. 23 E., M. D. M. in Storey County, Nevada, this 26th day of May, 1903.

Notice is hereby given that L. H. Taylor thereunto duly authorized by the Secretary of the Interior, for and on behalf of the United States of America, claims all the unappropriated waters of the Truckee River, both surface and underflow, at all seasons of the year, to the extent of three thousand (3000) cubic feet per second (150,000 Miner's inches measured under a four inch pressure);

That said water is claimed for irrigation and other beneficial uses on land within the basins of the Truckee, Carson and Humboldt Rivers in Washoe, Storey, Lyon, Churchill and Humboldt Counties in the State of Nevada;

That it is the intention to impound the said water, when the same is not required for the above uses, in a storage reservoir to be formed by the construction of a dam near this point to a height of approximately six (6) feet above the stream bed, whence it will be permitted to flow down the natural channel of the Truckee River to a point in the SW $\frac{1}{4}$  of Sec. 19, T. 20 N., R. 23 E. M. D. M. to a point where a dam will be built in said channel to a height of approximately twenty (20) feet and the water thereby diverted into a canal having a bed width of approximately twenty (20) feet and a depth of 13 feet, and conducted therein to the points of use.

This notice is posted on the right bank of the Truckee River at the site of the dam in said river near Tahoe City, Placer County, California and about 500 feet downstream from Lake Tahoe.

Taylor, thereunto duly authorized by the Secretary of the Interior, for and on behalf of the United States of America, claims all of the unappropriated waters of Truckee River, both surface and underflow, at the place where this notice is posted, at all seasons of the year, to the extent of (1500) fifteen hundred cubic feet per second (75000) seventy-five thousand Miner's inches measured under a four inch pressure);

That said water is claimed for irrigation and other beneficial uses on land within the basin of the Truckee, Carson and Humboldt Rivers in Washoe, Storey, Lyon, Churchill and Humboldt Counties in the State of Nevada;

That it is the intention to convey the said water from this point down the natural channel of Truckee River to a point in the Southwest Quarter of Section 19, T. 20 N., R. 23 E., M. D. M., where a dam will be built in the said channel to a height of about twenty (20) feet and the water thereby diverted into a canal having a bed width of approximately twenty (20) feet, and a depth of approximately thirteen (13) feet, and conducted therein to points of use.

This notice is posted on the left bank of Truckee River at a point about 100 yards above the head of the Steamboat Ditch and just west of the California-Nevada boundary line - in Sierra County, California, this 21st day of May, 1903.
