I do not support releasing Rod's instream flow analysis beyond California's offices. It reflects pre-decisional information that was based on unsubstantiated assumptions because of the intended use of the regimes. As I wrote in the e-mail below to Banky Curtis, these hypothetical flow regimes were only to assist CFG in their preliminary evaluation of potential benefits of TROA for Lahontan cutthroat trout. The regimes will most likely not be used in the TROA DEIS/DEIR because: 1) they are a set of hypothetical regimes and management strategy for pre-decisional analysis by CFG; 2) others in my office have not reviewed, commented or approved of them or the strategy for implementing them; and 3), they have no association with the development of the cui-ui/LCT recovery and management plans. In addition, the analytical foundation of the TROA DEIS/DEIR is yet to be determined. Since I have no idea if the regimes reflect how water may be managed in the future by the Tribe and FWS, I cannot confirm the validity of any interpretation or conclusion of possible impacts of TROA on LCT and cui-ui that others my derive from Rod's computer simulations using these regimes.

If you decided anyway to release Rod's report, I request that you incorporate this memo in it along with my May 22 and 24 memos to Bank Curtis.


