Here are a few descrepencies I found while I was reviewing and putting the notices into one notice. I think they may have been oversights, but just in case I wanted to run them by you and you can forward them to your group for clarification if need be.


- 1. Draft notice for petitions from USBR in description of existing permit 11605 (app 15673 Stampede) says direct diversion season is 1/1 through 12/31. This is incorrect * permit says direct diversion season is 4/1 through 11/1. The season cannot change, so I think this must just be an oversight. Any addition to the season constitutes a new water right. The new application for Stampede (A31487) does request year round diversion for both direct diversion and storage, so when A31487 is permitted, there would be direct diversion from 1/1-12/31 for the purpose of TROA.
- 2. Petition for Stampede: Re change under Points of Diversion to be added*.. Boca Dam cannot be added as a point of diversion. New points of diversion below the original water right would constitute a new water right. This POD is covered in new application 31487 for Stampede.
- 3. App 31487 stampede reservoir "Application seeks to appropriate 350 cubic feet per second (cfs) from January 1 to December 31 and up to 226,500 acre-feet (AFA) by storage from January 1 to December 31, in combination with existing Permit 11605. The maximum annual quantity of storage under this application and Permit 11605 is to be limited to 226,500 to acre-feet per annum (AFA)."

This should read (per the application) - "The total amount of water to be diverted from under this application and Permit 11605, whether by direct diversion or diversion to storage, shall not exceed 226,500 af per year.

The application 31487 Item 4b. limits both direct diversion and diversion by storage.

In addition, this is to confirm our conversation of this afternoon that I will identify the tables for the common points of rediversion, common places of use, and common purposes of use that are first shown in the portion of the notice for the petitions and reference those tables in the portion of the notice relating to the two new applications. If any one of your group has problems with this let me know as soon as possible - I will save the electronic version with all the tables included, and we can just switch back to that version. I think if we only have one set of common tables, people won't keep trying to figure if there are differences between them.
