DRAFT ORDER APPROVING A CHANGE IN THE PLACE OF USE OF LICENSE AND PERMITS OF THE UNITED STATES BUREAU OF RECLAMATION (Reclamation) AND CALIFORNIA DEPARTMENT OF WATER RESOURCES (DWR) IN RESPONSE TO DROUGHT CONDITION

Enclosed is a draft order in which the State Water Resources Control Board (State Water Board or Board) approves the petition to consolidate portions of the places of use for water rights owned by Reclamation and DWR that authorize diversion for the Central Valley Project and the State Water Project. This order is scheduled for consideration by the State Water Board at its Board meeting on May 19, 2009.

All interested persons and parties to the proceeding will have the opportunity to comment on the proposed order at the State Water Board meeting. All presentations should be limited to five (5) minutes. Comments should be limited to the general acceptability of the decision or possible technical corrections. Parties may not introduce evidence at the State Water Board meeting.

Parties must submit in writing comments or changes to the proposed decision they wish the State Water Board to consider at the meeting. All written comments must be received by the Board by **12 Noon on Monday, May 18, 2009.**
