APRIL 4, 2007 PUBLIC HEARING REGARDING DRAFT CEASE AND DESIST ORDER NO. 262.31-14 AND ADMINISTRATIVE CIVIL LIABILITY COMPLAINT NO. 262.5-44 AGAINST THE VINEYARD CLUB, INC.
