Mr. Kelly,

The letter in question was never a part of the Vineyard Club file. It was a generic letter sent out to all the parties on the mailing list. That is to say that it was not "removed" from the file because it was never part of the file. It is for this reason that it was not included previously. As soon as we realized that this letter (which your client has had a copy of for nearly two years) existed and may be relevant to your client, we immediately forwarded it to you. I have spoken with staff, and they assure me that there is no other documentation related to license 12831.

There are of course numerous emails between staff and myself as legal counsel pertaining to this enforcement action. These are not part of the file on license 12831 and you are in no way privy to them. Despite this fact, following is a log of emails. The receipt of this letter - just a couple of days from the date Exhibits and testimony are due, raises serious concern that the SWRCB, and particularly the Prosecution Team, may not have provided the Vineyard Club with access to everything in, or should be in, the Club's water right file.

In any event - and now that I have learned of the Division's "enforcement sweep," I would like all information related in any way to all inspections conducted in the Russian River watershed in accordance with this notice. I also again request that you provide me with all information the SWRCB has regarding the Vineyard Club's water right, the May 2005 inspection, the Inspection report, and the CDO and ACL, whether the Prosecution Team believes it is relevant or not. In order to be certain the Vineyard Club receives adequate time to prepare, as due process requires, I request you provide me this information by the close of business today.

In addition - I would like a privilege log of anything you are withholding,

whether e-mail communications or otherwise, so that it is part of the record.
