Thank you for your <u>letter of October 2, 2015</u>, indicating the status of gathering the remaining signatures for the proposed <u>Settlement Agreement</u> for the <u>Woods Irrigation Company CDO Hearing</u>. I am writing to see if it has been possible to gather the remaining outstanding signatures you mentioned in your letter: Helen Costa Tr., et al., Mark and

Valla Dunkel, Larry Vierra Tr. et al and Helen Peters Tr., et al. You also mentioned that it might be difficult to obtain the Dunkel, Vierra and Peters signatures.
