Dear Hearing Officers Spivy-Weber and Moore:



The party representatives are currently working on gathering signatures and/or formal entity board approvals to the settlement agreement and understand that the prosecution team will prepare a proposed order for the Board's consideration. We respectfully request an additional 60 days to submit the fully executed settlement agreement and proposed order to the Board.

One party to the proceedings, Modesto Irrigation District, has requested not to be a party to the settlement agreement but has indicated that it will not oppose the Board's entry of an order consistent with the terms of the settlement.
