- (e) Rules of court of (1) any court of this state or (2) any court of record of the Unites States or of any state of the United States.
- (f) The law of an organization of nations and of foreign nations and public entities in foreign nations.
- (g) Facts and propositions that are of such common knowledge within the territorial jurisdiction of the court that they cannot reasonably be the subject of dispute.
- (h) Facts and propositions that are not reasonably subject to dispute and are capable of immediate and accurate determination by resort to sources of reasonably indisputable accuracy.

As the court explains in Lockhard v. MVM, Inc. (2009) 175 Cal.App.4th 1452, at pages
