Whereas under the provisions of an
Act of Congress of the United States approved the twenty
eighth day of September A D One thousand eight-hun-
dred and fifty entitled An Act to enable the States of
Arkansas and other States to reclaim swamp and
mud flat lands in which Act the manner of selecting
and setting apart Swamp and Overflowed lands is
fully set forth: And whereas the Legislature of the
State of California has provided for the sale and convey-
ance of said lands by statutes enacted from time to
time: And whereas it appears by the certificate of the
Register of the State Land office numbered 2192 bearing
date November 25th A D one thousand eight-hundred
and seventy six and issued in accordance with the
provisions of law, that the tracts of Swamp and Over-
flowed lands hereinafter described have been duly
and properly surveyed in accordance with law: That
full payment has been made to the State for the
same and that J P Whitney is entitled to receive a
patent therefor: said lands being situated in San Joaquin
County and described as follows to wit: Township Nos
1266, 1267, 1816, 1821, 1822, 1855, and portions of 1278, and
1275 Swamp and Overflowed lands San Joaquin
County Townships Nos 1 and 2 North and 1 South
Ranges Nos 45 and 6 East Mount Diablo meridian
all of Township 1 N R 5 E excepting portions of said
1, 12, 22, 23, 24 and 25. Portions of said 25 and 26 in Sp
1 N R 4 E lots 22, 23, 24 and portions of said 26, 27, 28

State of California to be hereunto affixed bearing under
my hand at the City of Sacramento this the twenty fourth
day of November in the year of our Lord one thousand
eight hundred and seventy six.
