NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND NOTICE OF PUBLIC WORKSHOP

ON DRAFT PRIORITIZED SCHEDULE AND ESTIMATE OF COSTS TO COMPLETE INSTREAM FLOW STUDIES PURSUANT TO THE SACRAMENTO-SAN JOAQUIN DELTA REFORM ACT OF 2009

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold an informational workshop at its November 16, 2010 meeting to hear public comments on the draft report to the Legislature. A quorum of Board members may be present, but no Board action will be taken at the workshop on this item. The sole purpose of the workshop is to receive public input.

BACKGROUND

Water Code section 85087, contained in the Delta Reform Act, requires the State Water Board to submit to the Legislature by December 31, 2010 a prioritized schedule and estimate of costs to complete instream flow studies for two categories of rivers and streams by two specific deadlines: (1) "high priority rivers and streams in the Delta watershed, not otherwise covered by section 85086, by 2012"; and (2) "all major rivers and streams outside the Sacramento River watershed by 2018."

The report does not have regulatory effect nor does it constitute an official plan. It may however influence future planning processes and activities under the Board's obligation to protect public trust resources.

The State Water Board is especially interested in written comment letters that address the following areas:

1. Whether there are streams that should be added to the list.
2. Whether there are existing and adequate streamflow studies for streams that are on the list.
3. Whether there is other information available on likely costs that will help inform the Board.


