## State Water Resources Control Board

### Notice of Minor Change to Water Right Application A030794

The State Water Resources Control Board has initiated a minor change under Water Code section 1700.4, seeking to make changes to pending water right application A030794. The project associated with the application and minor change is in Mendocino County and would divert water from the Navarro River stream system.

### Summary of Water Right Application A030794

**Date of Filing:** The application was filed with the State Water Board on October 13, 1998.

**Source of Water:** The sources of water are an Unnamed Stream tributary to Donelly Creek and an Unnamed Stream tributary to Graveyard Creek, both of which are tributary to Anderson Creek thence the Navarro River.

**Amount:** The maximum amount of water requested for diversion is 25 acre-feet per year.

**Season of Diversion:** The season for diversion of water is from October 1 of each year through June 1 of the succeeding year.

**Point of Diversion:** Water will be diverted from two points:

- The first point is located at North 2,140,343 feet and East 6,178,722 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southeast quarter of the Northeast quarter of Section 36, Township 14 North, Range 14 West, Mount Diablo Base and Meridian.
- The second point is located at North 2,142,297 feet and East 6,176,879 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southeast quarter of the Southwest quarter of Section 25, Township 14 North, Range 14 West, Mount Diablo Base and Meridian.

**Purpose of Use:** The purposes of use for water are irrigation, domestic, and fire protection.

**Place of Use:** The place of use for water is 30 acres net within a gross 45 acres as follows:

- 30 acres within the North half of Section 36, Township 14 North, Range 14 West, Mount Diablo Base and Meridian
- 15 acres within the South half of Section 25, Township 14 North, Range 14 West, Mount Diablo Base and Meridian

## Summary of Minor Change

**Source of Water:** The source of water has changed by removing the second Point of Diversion located on an Unnamed Stream tributary to Graveyard Creek thence Anderson Creek thence the Navarro River.

**Season of Diversion:** The season for diversion of water has changed from October 1 of each year through June 1 of the succeeding year to December 15 of each year through March 31 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion has been changed to 5.9 acre-feet per year.

**Points of Diversion:** The points where water will be diverted has been changed by removing the second Point of Diversion.

**Purposes of Use:** The purposes of use for water have been changed by adding dust control.

**Places of Use:** The place of use for water has been changed to 27 acres within the North half of Section 36, Township 14 North, Range 14 West, Mount Diablo Base and Meridian.
