Point of Diversion:
South 1,980 feet and East 750 feet from Northwest section corner of projected Section 23, Township 3 North, Range 10 West, Mount Diablo Base and Meridian, being within the Southwest quarter of Northwest quarter of said Section 23.

Annual Storage Amount:
6.4 acre-feet per year of collection to storage
6.4 acre-feet per year of withdrawal from storage

Season of Diversion:

November 1 of each year to April 30 of the succeeding year.

Purposes of Use:

Domestic, Stockwatering, and Recreational

Place of Use:

Within Southwest quarter of Northwest quarter and Northwest quarter of Northwest quarter of projected Section 23, Township 3 North, Range 10 West, Mount Diablo Base and Meridian.
