ERRATA FOR THE DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE EAGLE CREST ENERGY PUMPED STORAGE PROJECT (STATE CLEARINGHOUSE NO: 2009011010)

The State Water Resources Control Board (State Water Board), as lead agency under the California Environmental Quality Act (CEQA), is issuing an errata for the Draft Environmental Impact Report (DEIR) for the Eagle Crest Energy Pumped Storage Project. The State Water Board has been made aware of a misprint in Table 5-5 in section 5 of the DEIR. The enclosed Table 5-5 is the correct table and should replace the existing table. The analysis in the DEIR used the correct information in order to draw conclusions about the potential cumulative impact of groundwater pumping.
